ORDINANCE NO. 15-0410**

**AN ORDINANCE OF THE CITY OF KENMORE,
WASHINGTON, RELATING TO ROAD (STREET)
STANDARDS, ADOPTING THE 2016 ROAD STANDARDS,
AND AMENDING AND REPLACING CHAPTER 12.50 OF
THE MUNICIPAL CODE.**

WHEREAS, the 1993 update of the King County Road Standards is effective in the City, pursuant to KMC 12.50.010.; and

WHEREAS, City staff has proposed the adoption of new road standards to replace the King County Road Standards; and

WHEREAS, the City's Responsible Official under the State Environmental Policy Act has issued a determination of non-significance for the proposed road standards; and

WHEREAS, the Washington State Department of Commerce was notified of the proposed amendments pursuant to RCW 36.70A.106; and

WHEREAS, on November 9, 2015, the City Council was presented with and considered the proposed road standards, titled "City of Kenmore 2016 Road Standards," together with a proposed new Chapter 12.50 KMC; and

WHEREAS, on December 14, 2015, the City Council held a public hearing on new Chapter 12.50 KMC and the City of Kenmore 2016 Road Standards; and

WHEREAS, the City Council desires to adopt the new Chapter and Road Standards;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF KENMORE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Adoption of New Chapter 12.50 of the Kenmore Municipal Code. The City Council amends and replaces Chapter 12.50 of the Kenmore Municipal Code with a new Chapter 12.50 of the Kenmore Municipal Code as set forth in Attachment A, attached hereto and incorporated herein by reference.

Section 2. Adoption of 2016 Road Standards. The City Council adopts the "City of Kenmore 2016 Road Standards," a copy of which shall be placed on file in the office of the City Clerk.

Section 3. Effective Date. This Ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of publication.
